AGREEMENT

This Agreement made between the Retail Clerks' International Protective Association by its agents, Local Union No. 930, of Two Harbors, Minnesota, party of the first part, and merchants doing business in Two Harbors and within the jurisdiction of Local No. 930, R. C. I. P. A., party of the second part.

WITNESSETH: That the party of the first part, in consideration of the mutual promises of the parties of this contract, promises and agrees:

- 1. That it will exercise its influence to advance the interests of the party of the second part as employers of Union Labor and will enhance the interest of their employers by distributing printed matter and visiting the various industrial organizations of the city and advising them to patronize said party.
- 2. That it will loan without cost to the party of the second part Store Card No. as below. This card is, and shall remain the property of the party of the first part and must be surrendered by the party of the second part upon violation of any of the provisions of this agreement upon demand of the party of the first part, through its Secretary or Business Agent.
- 3. The party of the second part, in consideration of the mutual promises of the parties of this contract agrees:
 All employes over sixteen years of age shall become members of the party of the first part within 30 days after commencing work and remain in good standing during the life of this contract while employed by the party of the second part. Party of the second part agrees not to retain in their employ after being notified by the Secretary or Business Agent, any employe who has not procured his or her membership Book, correctly stamped each month by the Local R. C. I. P. A., and no more than one employe under sixteen years of age shall be allowed to work to each five Union clerks or major fraction over five members employed.

In case party of the second part employs no clerks, he may employ no more than one under sixteen years of age.

- 4. It is hereby agreed that party of the second part will receive and consider a list of idle members of Local No. 930, R. C. I. P. A., for investigation pursuant to employment.
- 5. That 8½ hours shall constitute a day's work, said 8½ hours to be worked between the hours of 8:00 a. m. and 5:30 p. m. on all days of the year, except on the hours of 8:00 p. m., six days preceding Christmas when said 8½ hours to be continued to 8:00 p. m., except Christmas Eve and New Year's Eve, when store is to be closed at 5:30 p. m.
- 6. Party of second part shall grant one day for Clerks' Picnic Day and stores to be closed at 5:30 p. m. the day previous, and to keep stores closed on all legal holidays with the exception of Good Friday, Lincoln's and Washington's birthdays.
- 7. It is understood that the party of the first part shall care for the stock of the party of the second part in such a manner as to protect it from damage before leaving the store.
- 8. And that the party of the second part agrees not to sell any goods on Sundays or the legal holidays with the exception of marine trade and emergency orders, which may be filled at any time and by any clerk.
- 9. It is understood and agreed by both parties to this contract that no member of the R. C. I. P. A. shall be discriminated against or denied employment because of his or her activities in the matters of the R. C. I. P. A.
- 10. Party of the second part, in case he employs no clerks, will be given the use of the Store Card of the R. C. I. P. A., providing he recognizes, signs this agreement and lives up to the same closing hours as stores employing Union clerks.
- 11. Party of the second part agrees to take no orders for delivery that will cause any employes to work longer than hours specified in this agreement.
- 12. Party of the second part agrees that any employes laid off on account of slack business conditions shall be given preference when said conditions improve so as to require additional clerks. And no employe under the age of sixteen shall take the place of any employe over the age of sixteen, laid off on account of slack conditions.
- 13. The party of the first part agrees to furnish to the party of the second part, in duplicate form, to be used in such place of business as a working rule, copy of this agreement, and the same shall be posted where it will be accessible to all parties concerned.
- 14. This agreement shall expire Dec. 30th, 192...., but parties to this agreement may work under the terms and conditions of this agreement for a period of thirty days thereafter, pending signing up of an agreement for ensuing year.

PARTIES OF THE SECOND DADE

15. This agreement shall be in force and effect from this 1st day of Jan. A. D. 192, at Two Harbors, Minn.
