Memorandum of Agreement

By and Between the Superintendent of Schools and the Board of Education of the Livingston Manor Central School District, hereinafter referred to as "the District" and the Livingston Manor Central School School - Related Professionals Association, hereinafter referred to as "the Association";

Whereby, the parties agree to revive and incorporate the provisions of the negotiated contract between them that is set to expire on June 30, 2008, into a one year successor agreement effective July 1, 2008 and terminating on June 30, 2009, except as modified by the following provisions:

1. Article 6 – Working Conditions

6.9 Uniforms – Modified to reflect a 4% increase in the uniform allowance for cafeteria employees and the School Nurse in 2008-2009; (\$99.43)

2. Article 10 – Salary and Other Benefits

10.1 Salary Schedule – Modified to reflect a 4% raise in base salary for all current employees in 2008-2009 and a 1% increase on hire rates for 2008-2009.

10.2 Longevity Increments – Modified to reflect that the existing longevity increments for five (5), ten (10), fifteen (15), and twenty (20) years of continuous service for ten (10) and twelve (12) month employees shall be increased by 4% for 2008-2009.

So Agreed this 20 day of May, 2008, subject to ratification by the respective constituencies.
