**MEMORANDUM OF AGREEMENT
BETWEEN THE ELMONT UNION FREE
SCHOOL DISTRICT AND THE ELMONT
ELEMENTARY ADMINISTRATORS' ASSOCIATION**

It is hereby agreed by and between the Board of Education of the Elmont Union Free School District [hereinafter "Board"] and the Elmont Elementary Administrators' Association [hereinafter "Association"] that all the terms and conditions of the collective bargaining Agreement between the Board and the Association are hereby continued in full force and effect, except as modified below.

1. Duration: July 1, 2006 through June 30, 2009.

2. Salary Increases: All salaries shall be increased by 3.0%, 3.5% and 3.75% in each year of the contract, respectively with the exception of the Principal on Special Assignment whose increases shall be 1.5%, 1.5%, 0%.

3. Sick Leave: Unit members shall receive 16 days of sick leave per year. The number of unused sick days shall cumulative to 240 days including unused sick leave.

4. Life Insurance: The life insurance shall be increased to \$40,000 for each unit member.

5. Unit members with the permission of the Superintendent based upon the needs of the District may work up to one extra day over the summer at the administrator's per diem rate.

6. This Agreement is subject to ratification by the Board of Education and membership of the Association.


