# 2014 Reporting of Sexual Assault: Institutional Comparisons

## **Abstract**

Institutions of higher education are required to submit annual reports of sexual assault crimes to the Department of Education under the Clery Act. The Department of Education makes this data publicly available. Two primary measures are used to assess reporting of assault on campus: the Assault Reporting Ratio (ARR) and the Reporting Rate per 10,000 students (R10K). These measures are easily calculated and can be used to assess practices and policies that impact the reporting of sexual assault on campus.

The ARR and R10K are rate comparisons, a method widely used in public health. These rate comparisons measure how close the institution is to reporting the anticipated number of assaults occurring on campus. Use of these measures allows comparisons between institutions and between years in the same institution. They serve as benchmarks to identify best practices and the impact of legal changes.

The Assault Reporting Ratio compares the reported number of assaults to an estimate of the expected number of assaults. The expected estimate is based on gender-specific assault rates, and college-level (undergraduate or graduate) enrollment based on anonymous survey data. The ARR is expressed as a percentage. An ARR of 100% indicates that the school is counting all of the assaults predicted by national surveys. The R10K is the reported number of assaults per 10,000 students, calculated from the data provided by the institution.

During 2014, 10,607,238 students were enrolled at 1,332 institutions, 82% undergraduates and 18% graduates. A total of 6,429 sexual assaults were reported for all institutions combined. A quarter of institutions (25.7% or 343 colleges) reported no sexual assaults. The summary statistics include all schools with zero reports.

Overall, in 2014, there were 6 reports of sexual assault per 10,000 students (R10K measure). At individual colleges, the range of assault reports was from zero to 215 reports per 10,000 students with a median of 4 (10 IQR). The mean R10K was 9.5 (16.9 SD).

The expected number of assaults in the same population was 282,399. The overall ARR for the country is the reported assaults (6,429) divided by the expected number of assaults (282,399). This figure, 2.3%, indicates that 97.7% of the expected assaults are not reported to the colleges. The median ARR was 1.6% and the mean ARR was 3.5%.

The standardized measures can be used to evaluate institutional policies, changes in programs, and procedures for reports. Attachments include ranking of all institutions in analysis by each measure and Excel, and csv delimited data files.

## Overview of 2014 Report

Institutions of higher education are required to submit annual reports of sexual assault crimes to the Department of Education under the [Clery Act](#). The Department of Education makes this data publicly available. In [2013](#) this data was analyzed using standard public health measures to rank and evaluate institutions on the reporting of assault. Two primary measures are used to assess reporting of assault on campus: the Assault Reporting Ratio (ARR) and the Reporting Rate per 10,000 students (R10K). These measures are easily calculated and can be used to assess practices and policies that impact the reporting of sexual assault on campus.

The ARR and R10K are rate comparisons, a method widely used in [public health](#). These rate comparisons measure how close the institution is to reporting the anticipated number of assaults occurring on campus. Use of these measures allows comparisons between institutions and between years in the same institution. They serve as benchmarks to identify best practices and the impact of legal changes.<sup>1</sup>

The Assault Reporting Ratio compares the reported number of assaults to an estimate of the expected number of assaults. The expected estimate is based on [gender-specific](#) assault rates, and [college-level](#) (undergraduate or graduate) enrollment based on anonymous survey data.

A higher ARR indicates that the college is receiving reports of more of the assaults that are occurring, closing the gap between the estimate of expected assaults and the assaults reported to the institution. Eventually higher ARR percentages are better for student safety as reports should help to hold perpetrators responsible.

The analysis included 1,332 institutions. Nearly a quarter (24.4%) of institutions reported no sexual assaults. For every 10,000 students enrolled in higher education institutions with residential facilities, there are 6 reports of sexual assault made to the college or other authorities.

<sup>1</sup> This year's report features a major change from last year's report: the analysis is adjusted for graduate enrollment. Because of this adjustment, no comparisons should be made between the 2013 report and the 2014 report.

In a hypothetical undergraduate population, for every 10,000 students (50% female and 50% male) there are 325 assaults expected annually. In the group of 10,000 undergraduate students, approximately 1,300 will experience sexual assault during college. The overall 2014 Assault Reporting Ratio was 2.0% indicating that 98% of assaults are not reported to the authorities given the expected number of assaults.

### Data Sources

Data were downloaded on January 15, 2017 in the form presented by the Department of Education from the [Campus Safety and Security](#) website.<sup>2</sup> Data in this analysis and the accompanying files are limited to schools who identified as 4-year colleges (public or private) with residential programs. Schools that did not submit enrollment data were not included. Undergraduates and graduate students are included in the analysis.

### Methods

Calculation of total sexual assault reports at each institution were done using the reports submitted to the Department of Education. The data were restricted to the main campus for each institution as identified within the data repository. The total number of assaults reported, on and off-campus, was the sum of rape, fondling, statutory rape, and incest counts.

Rates per 10,000 students were calculated as the total number of assaults divided by the student enrollment. For ease of interpretation, the percentage was converted to a per 10,000 student figure.

Annual expected numbers of assaults were based on gender-specific rates (female or male) and enrollment status (undergraduate or graduate). Using the institutional enrollment information submitted to the National Center for Education Statistics variables for percent and count of female and male undergraduates and graduates were constructed.

Each combination of gender and enrollment status had a specific rate of sexual assaults reported anonymously in national surveys. The national survey data is cross-sectional and asks the student for the number of experiences of nonconsensual penetration or sexual touching involving physical force or incapacitation. All years of student experience are included in the survey measure. To account for the four years of time in college during which an assault could occur, the rates were divided by 4 and applied to each population.

For example, undergraduate females have reported in anonymous surveys, an assault rate of approximately [20%](#), which could have been from an event that occurred at any time during their current time in college (1-4 years). The 20% rate is divided by 4 years and the result, .05 rate is applied to the number of female undergraduate students at the institution. This creates a gender-specific, enrollment-level expected count for the group. The same method was applied to each of the groups. [Rates of assault](#) for other groups were: undergraduate males 6%, graduate females 8.8%, and graduate males 2.2%.

Expected assaults for each group were summed together to create an overall annual number of assaults for the institution adjusted for the gender and enrollment characteristics.

The Assault Reporting Ratio is the reported number of assaults divided by the expected number of assaults. The ARR is expressed as a percentage and indicates the fraction of achievement in getting the anticipated number of assaults reported at each institution. A higher ARR indicates a smaller gap between the anonymous survey data and the actual reports received.

The ARR calculation is an estimate based on available data and an equal division of the rates over time in college. Future ARR calculations could consider other approaches to calculate the expected number of reports.

#### Statistical Summary of 2014 Data

The analysis of data is limited to institutions, public and private, with 4-year programs and on-campus residential facilities. Graduate students at the same institutions are included in the analysis. During 2014, 10,607,238 students were enrolled at 1,332 institutions, 82% undergraduates and 18% graduates. A total of 6,218 sexual assaults were reported for all institutions combined. A quarter of institutions (24.4% or 325 colleges) reported no sexual assaults. The summary statistics include all schools with zero reports.

Overall, in 2014, there were 6 reports of sexual assault per 10,000 students (R10K measure). At individual colleges, the range of assault reports was from zero to 215 reports per 10,000 students with a median of 4 (10 IQR). The mean R10K was 10.2 (18.1 SD).

The expected number of assaults in the same population was 317,852. The overall ARR for the country is the reported assaults (6,218) divided by the expected number of assaults (317,852). This figure, 2.0%, indicates that 98% of the expected assaults are not reported to the colleges. The median ARR was 1.4% and the mean ARR was 3.2%.

#### Limitations

The major limitation of the reporting data is that the Clery data does not indicate when the assault occurred, only when it was reported. This raises problems when institutions report assaults that they only acknowledge in that year.

The data used in the analysis was as stated by the institution to the Department of Education. Some of the main campus figures may be inaccurate for the universities with a large online enrollment and did not distinguish between the types of students. Notable in this category are Liberty University and Grand Canyon University.

Another major limitation is the variability in reporting policies among colleges. A major deterrent to reporting is the institutional restriction on reporting. For example, in 2014 Cornell University limited reporting for students to 1 year after the event. Other schools

in the same time period had no limit on the time for reporting a sexual assault. This could result in reporting differences.

An analysis of reporting data by [Yung](#) showed that colleges increase reports while an OCR investigation is underway or recently completed. Institutions that are currently under investigation or that were recently investigated tend to report more cases.

The Chronicle of Higher Education has maintained a [list](#) of the year that institutions are under OCR investigation. This information is not available on the Campus Safety and Security website of the Department of Education.

### Conclusion

Sexual assault on campuses is not declining according to the [national](#) or individual institutional surveys. Reporting rates have not increased at most institutions based on this data. The majority of sexual assaults – 98% – are not reported, or reports are not identified as assaults, indicating that there are barriers on campus that discourage victims from coming forward. This analysis should be used to identify institutions which have higher ARRs, compared to their peer institutions, to understand what does work to encourage victims to report assaults.
